A Damage fee will be charged in an amount not exceeding \$350.00 for each carpet or seat burn if any. Client is responsible if any member of party physically damages limousine, cost of repairs and replacement parts will be at clients expense. A Sanitation fee will be charged in amount not exceeding \$350.00 for excessive clean up (such as: liquid damage (saturated carpets), vomit, food damage to carpet). There will be a \$25.00 charge for each piece of broken or missing glassware. Drug use is prohibited by law. Any fines will be paid for by the customer. The chauffeur has the right to terminate service without refund (if there is blatant indiscretion on the part of the client(s)). It is Illegal to stand through the sunroof while vehicle is moving. Smoking is not permitted in our limousines! 4. Overtime pay will apply after the first 15 minutes of prearranged time described on the run sheet and will be charged as an additional hour. 5. Not responsible for delays or the termination in winter caused by unsafe road conditions or weather conditions (ie. Traffic, accidents, etc.). 6. Not responsible for articles left in the limousine. 7. Balances to be paid cash to the driver on the run date before the beginning of the run. 8. Vehicles cannot be loaded beyond seating capacity.
